The Vice-Chair – OSG Sector: Roger McKenzie:

Advised that Equality and Diversity work continued and OSG were currently reflecting on 'where we've been and where we're going'.

Need to ensure partnership work continues and is taken forward under new arrangements.

Vice Chair - Business Sector: Mr Sarindar Sahota

On behalf of the Business Council congratulated Roger on his OBE.

Reminded Members that the West Midlands had been the hardest hit by the recession and reinforced the value and strength of partnership working – this was not to be lost sight of.

Shared his disappointment that the short time working scheme/subsidy had not been established in the current economic climate.

The Construction Action Plan had been valuable in helping the manufacturing industry and imperative that discussions were continued at the Assembly.

The Chairman:

Thanked the Vice Chairs and advised that Cllr David Sparks (Dudley) had been nominated by his political group to serve on the Assembly as the new Vice Chair for local government.

Cllr Ken Taylor (Chairman of WMLGA), nominated Cllr David Smith to continue his Chairmanship of the Assembly. This was seconded by Cllr Chris Saint.

6. **Report of the Chief Executive and Company Secretary**

The Assembly was provided with an update on general corporate and financial issues:

2008-09 Financial Statements

Preparation for Winding Up the Assembly

The report advised that, at its meeting on 10th June 2009, the Board agreed to approve the Draft 2008-09 Financial Statements presented by Clement Keys upon a recommendation from the Finance & Audit Committee, who met on 30th June.

Members were advised that the the final accounts, as approved by the Audit Committee, would be placed on the Assembly website and filed with the Department for Communities and Local Government

The Assembly:

Endorsed the Board's approval of the 2008-09 Financial Statements of the West Midlands Regional Assembly and appointment of Clement Keys as auditors for 2009-10

Noted the proposed approach for Winding Up the Assembly

7. Regional Spatial Strategy Phase Two - Examination in Public

The Chairman commenced the item by thanking Mark Middleton, John Pattinson, the Assembly Planning Team and all Local Authorities for the tremendous contributions they had made to the Examination in Public to the RSS Phase 2.

Mark Middleton took Members through the report as follows:

Paragraph 5 - Sustainability and Habitat Protection

5.3 Judicial Review challenge to the East of England Regional Spatial Strategy:

Advised that a letter was put forward to the Panel drawing their attention to this case.

Paragraph 6 - Level and Distribution of Housing

The key word coming from the EiP was deliverability, particularly in the current economic circumstances.

Paragraph 7 - Employment Land & Commercial Development

It was highlighted that the discussion on the policies in the Phase Two Revision in these areas were limited which was disappointing given the need to develop the regional economy.

Paragraph 8 - Sub Regional Sessions

Mark gave thanks to local authority colleagues who took the lead on these sessions not only for themselves but for the Assembly aswell.

Paragraph 9 - Middle Quinton Ecotown

This proposal on the south Warwickshire/south Worcestershire boundary was not part of the Phase 2 Revision strategy. It was however accorded a full session in its own right in light of the Government's interest in promoting ecotowns across England. There was little support for the proposal outside the promoters of the scheme themselves.

Paragraph 10 - Implementation

Mark advised that much time had been spent during the EiP in debating the impact of the current global recession on the deliverability of the Phase 2 Revision.

The final monitoring and implementation session pulled all these debates together and looked at the Assembly's recently-submitted Implementation Plan Supplement.

The Assembly **NOTED** the issues that arose during the EiP and gave their support and gratitude to the region's local authorities for their active support.

8. Regional Spatial Strategy Phase Three – Options Document

The Assembly were updated on the consultation arrangements related to the RSS Phase Three Revision Options consultation document and the proposed process for completing the RSS Phase Three Revision.

The following comments were made:

- Requested to be mindful of Parish Councils and the tight deadlines for consultation.
- Tourism is increasing at the moment as people could not afford to holiday abroad in the current economic situation. If managed properly, this could be sustained up to and including the 2012 Olympics.
- Gypsy and traveler communities were very varied and their unmet accommodation need had to be planned for carefully both at the regional and local level.
- Concern was raised regarding the future of the Phase 3 and the tremendous amount of work that had been done - if Phase 3 goes to SIRS it may be delayed or disappear altogether.
- Tourism wasn't getting enough recognition, there needed to be development of existing and new levels of tourism.
- Members were reminded that the 2012 Olympics was also the Paralympics.
- Some planning authorities had concerns regarding Gypsy and Traveller sites – the surveys on which the numbers were based represented actual need. The options addressed aspirations, though some felt this influenced the surveys.
- Tourism was also about the environment not just revenue from expansive venues. There was a need to remember and promote walks/countryside and healthy living.
- Broadband in rural areas and how businesses are linked to the rural communities - when laying cables can the cable companies and public services work together. Could this perhaps be a policy to be included in Phase 3?

The Assembly **NOTED**:

- (a) the consultation arrangements for the RSS Phase Three Revision Options and
- (b) arrangements for the Assembly and GOWM to review the process for taking forward the Phase Three work through either a revised RSS or single Regional Strategy following the Phase Three Options consultation.

9. WMES Delivery Framework Monitoring and Update

Members received a report from Philip Amison and Mark Pearce from AWM and were requested to consider the outputs from the first annual *monitoring and update of the West Midlands Economic Strategy (WMES) Delivery Framework*.

The following comments were made: -

- This was another great example of partnership working.
- There are still challenges to be met in skills
- Need to be mindful that the next wave of the recession will hit the public sector so there is a need for the document to be flexible to encompass change.
- Too little attention given to deep rural areas – internet and broadband are needed for promotion of rural areas/services. Government funding is needed.
- There is a need to persuade Government that wage subsidy is needed.
- Members queried the wording in paragraph 2.7.1 [stating that there was plenty of existing evidence to demonstrate that activity of this sort does yield economic benefit](#). It was requested that the wording be amended from: -

'activity to safeguard natural and agricultural assets has traditionally failed to demonstrate economic benefit.'

to:

'slower than expected progress in demonstrating economic benefit.'

The Assembly **NOTED** the first annual Monitoring Report against the WMES Delivery Framework and **ENDORSED** the updated WMES Delivery Framework.

AGREED that the wording be changed to paragraph 2.7.1 as outlined above.

10. SNR Change Management Update – Outlining Partnerships and Committees -

Members were updated on the SNR Change Management Plan.

The Assembly **NOTED** the report.

11. Delivering a Sustainable Transport System (DaSTS)

The Assembly were advised of the region's response to Department for Transport's (DfT) 'Delivering a Sustainable Transport System' (DaSTS) process.

Members requested that a copy of Stage 1 be circulated to them.

The Assembly **NOTED** the details of the process.

ACTION to circulate Stage 1 to Members.

12. Parliamentary Regional Accountability – West Midlands Select Committee

The Assembly were provided with an update on the current and future activity of the West Midlands Select Committee.
